## A MESSAGE FROM CHIEF HOUCK

As you may have heard from the NPD social media posts, we contacted a person of interest in this. He denied being the individual, but did completely erase all of his social media accounts and erased his phones before we could get warrants to search them. Now I know people are innocent until proven guilty, but I break out into a panic sweat if I can't find my phone, so erasing the data on two phones seems a bit extreme for an innocent person. I also don't know why a person would do that to their social media accounts, but I am old so I may not understand what the kids are doing these days. Those things, in addition to the fact there has been no new incidents, makes me feel we had the right guy and he knows we are watching him.

7300 BLK 121st PL SE

1130am—Warrant Arrest

NPD spotted a suspicious vehicle in the area. As they approached the vehicle, one person ran off. ## 1130pm—Suspicious Circumstances

NPD received a call reporting that a man was out on his balcony yelling about needing to be rescued. When NPD arrived the man began yelling that he had just killed his whole family. NPD officers began talking to the man from down below while waiting for additional officers from KCSO to arrive. Once they arrived and kept communicating with the man, NPD officers entered the house. It was

determined that nobody was injured and that the man was likely suffering from mental health issues. The man was taken to the hospital for an evaluation.

A woman called to report that her car had been broken into sometime in the previous three hours. The woman reported that her purse containing her ID, credit cards, etc. was stolen.
